a. SCHOOL LEADER & OPERATIONS REPORT

- i. Shifted into Phase 3 of Remote learning since updated guidance. Planned Instruction is occurring and students are receiving new content/instruction each week.
- ii. Beginning to dig into planning for return in the fall and any changes that may need to occur as a result of 2020 closures.
- iii. Have had all conversations with existing teachers around plans for next year. All but 3 teachers intend to return and all nonteaching positions are planning on returning. All attrition based new hires and growth new hires are complete with the exception of an upper grades math teacher. With Board approval, looking to use CARES Act funding in order to add additional Social worker for SY20-21. This position would ultimately be absorbed into the general budget as DRCS grows and CARE Act funding expires.
- iv. Trailer project underway. Mandrel in contact with Shift. Permitting application process. Project to start in early-mid June.
- v. Operations team doing planning around how to close out the building from SY19-20 and reopen in SY 20-21

b. FINANCIAL REPORT

- i. Current-year bottom trending upward despite challenges with Special Education funding as a result of changes to student count processes due to COVID-19 closure. Team actively working with CSO and Pat's team to address data gaps.
- ii. Philadelphia District Budget for 20-21 will be key driver for Deep Roots in 21-22
- iii. Recommend moving forward with the same auditor for next school year.
 Funding line already included in SY20-21 budget draft and would be inherently approved with the budget. Sooner "thumbs up" will allow DRCS/CC team to get a jump via remote processes. <<Finance Committee comfortable moving forward.>>
