School Report from Lucilla Perry, CEO

- Intro to John Widmer! Focusing on attendance and facilities
 - 95% daily attendance
 - Current average 88% (daily)

- We're aiming for 44% we're at 27%. Still in range for low 30s which is comparatively strong
- Attendance incentives are still
- Specialized services
 - We are seeing an increase in students in the lower grades in process
 - Debi commented schools across the board are seeing an increase in education populations in lower grades. We should also explore how to support students in exiting.
- Instruction
 - Heggerty started Jounce coach supported a strong start to it
 - Another coach supporting on planning and data tracking
 - ANet is next week
 - Coaching contract coming to an end on April
 - Skyrocket will continue
- Charter Renewal
 - Submitted to charter office
